1. Call to Order.

5. Discussion of Budget Workshop.

City Secretary, Linda Lakich, reported to Council that the effective tax rate is 0.26994 and the rollback rate is 0.28851. She explained that because property values have increase that the City's current tax rate of 0.27312 will produce an increase in tax revenue. She also told Council that the approval of the resulting tax increase will be on the next council agenda along with setting up public hearing dates. Code Enforcement Officer, Ford Stein, told Council that he would like to increase issuance fees for plumbing, electrical and mechanical permits from \$5 to \$15.

A discussion of General Fund revenues and expenditures took place including projected tax revenues and budget increases requested by department heads.

The City Secretary told Council that Hotel Occupancy Tax Fund revenues have increased during the current year by approximately \$100,000 with the addition of the two new hotels on the south side of town.

Council will discuss the Utility Fund at the next Budget Workshop.
