The City Council of the City of Columbus, Texas, met in regular session on Thursday, April 25, 2013 at 6:30 p.m., in the Council Chambers of City Hall located at 605 Spring St., Columbus, Texas, with the following present:

1. Call to Order.

Mayor Dwain Dungen called the meeting to order at 6:30 p.m.

2. Pledge of Allegiance and Invocation.

Mayor Dungen led the Pledge of Allegiance and Invocation.

3. Consent Agenda.

- a. Approval of Invoices.
- b. Approval of Minutes of April 4, 2013 Special Meeting.
- c. Approval of Minutes of April 11, 2013 Regular Meeting.

- e. Approval of Quarterly Investment Report for the Quarter Ended March 31, 2013.

Councilman Schonenberg made a motion to approve the Consent Agenda as presented. Councilman Axel seconded the motion.

4. Consideration and Action to Approve Invoices from B&D Graphics.

Councilman Schonenberg made a motion to approve the invoices from B&D Graphics. Councilman Rankin seconded the motion.

6. <u>City Manager's Report including Hazardous Waste Collection Event, 2012 Water System Improvements, and Cardinal Hill Elevated Storage Tank.</u>

City Manager, Donald Warschak, presented his City Manager's Report, a copy of which is attached to these minutes.

7. Public Hearing Regarding Dangerous Dogs and Animal Care.

The Mayor opened the public hearing at 6:36 p.m.

Mayor Dungen asked if anyone would like to speak. No one responded.

8. Consideration and Action to Approve Ordinance 152-13 Animal Control.

Mayor Dungen explained that the ordinance as presented had all of the changes which Council had discussed in previous meetings. He asked if anyone on Council had any comments, and no one did.

Councilman Woodall made a motion to approve Ordinance 152-13 Animal Control as presented. Councilman Axel seconded the motion.

9. Consideration and Action to Approve Ordinance 153-13 Speed Limits-Highway 71 South.

Donald Warschak told Council that he had received a memo from TxDOT proposing new speed limits on Highway 71 South. From the Interstate to in front of Comfort Inn the speed limit would be 40 miles per hour, from there south to Ratliff Creek it would be 50 mph, from Ratliff Creek for another 0.2 miles it would be 55 mph, and from there to the airport it would be 65 mph. He told them that Ordinance 153-13 reflects the suggested speed limits within the city limits from Interstate 10 to Ratliff Creek.

Councilman Schonenberg made a motion to approve Ordinance 153-13 as presented to set speed limits on Highway 71 South. Councilman Tesch seconded the motion.

10. Consideration and Action to Approve Appointment of a Library Advisory Board Member.

Mayor Dungen told Council that the appointment to the Library Advisory Board was Roger Wade.

Councilman Rankin made a motion to approve the appointment of Roger Wade to the Library Advisory Board. Councilman Tesch seconded the motion.

Councilman Schonenberg made a motion to authorize the mayor to enter into negotiations for the City regarding real property as discussed during the executive session. Councilman Axel seconded the motion.

13. Consideration and Action to Adopt Post Issuance Compliance Policy and Procedure.

The City Secretary explained that the city's bond counsel had suggested that the City adopt a formal written policy for handling post issuance compliance issues on bonds issued. Following these procedures will ensure that the City's bonds remain tax exempt for federal income tax purposes. She explained that the policy includes procedures for things like record keeping, filings, use of proceeds, investment of proceeds, and payments.

Councilman Schonenberg made a motion to adopt the Post Issuance Compliance Policy and Procedures as presented. Councilman Rankin seconded the motion.

The vote was as follows:

14. Consideration and Action to Review City of Columbus Financial Management Goals and Objectives.

The City Secretary told Council that the current policy requires that they review the Financial Goals and Objectives annually. She also said that she had made no changes since last year and asked if they had any changes to suggest. Councilman Rankin asked that the policy on transfers between funds be clarified. After additional discussion Council asked for time to review the policy and that it be included in the next agenda.
