1. Call to Order.

Mayor Dwain Dungen called the meeting to order at 6:30 p.m. He explained that Councilman Axel was absent due to illness.

4. Consideration and Action to Appoint a Mayor Pro Tem.

8. Public Hearing Regarding Panhandling.

Mayor Dungen opened the Public Hearing at 6:36 p.m.

City Attorney, Pat Gillespie, stated that after the last Council Meeting she spoke with Texas Municipal League representatives about putting together a city ordinance to deal with panhandling. They gave her a sample ordinance which she adapted for Columbus. Council was given the proposed ordinance for review. Pat stated the proposed ordinance is complaint driven so that police can respond if someone is uncomfortable about being approached. In addition, the police can respond without complaint if traffic is being impeded. Chief Lattimore said that he had reviewed the proposed ordinance and that it is very workable. There were no other comments or questions.
