### 6. City Manager's Report Including Sales Tax, Aerator Project, and Auto Read Meter Project.

City Manager, Donald Warschak, presented his City Manager's Report, a copy of which is attached to these minutes.

### 7. <u>Consideration and Action to Approve a Manufactured Home Permit for 1428 Crockett Street, as requested by Sean Sutton.</u>

Mayor Dungen commented that the permit application was not complete, since there was no certificate of title or a plat attached, and asked if all of the items included in the application are required. Code Enforcement Officer Ford Stein stated that the applicant was waiting for approval before purchasing a manufactured home. Councilman Rankin stated that he would like to see a copy of the plat showing

The Library requested closures of the area within the gates in front of the Elementary School as part of their Summer Reading Program activities.

Councilman Schonenberg made a motion to approve the closure of Bowie Street from Jackson to Houston for the Nesbitt Memorial Library events as requested. Councilwoman Gobert seconded the motion.

Councilman Hernandez made a motion to approve the closure of Legion Drive from Veterans Drive to Legion Circle for Independence Day activities as requested. Councilman Rankin seconded the motion.

### 13. <u>Consideration and Action to Approve Resolution 148-15, a Resolution Consenting to a Change in Columbus Community & Industrial Development Corporation Bylaws.</u>

Mayor Dungen stated that this resolution, which changes the number of CCIDC Board members allowed who can reside outside of the city limits, had been discussed at the last City Council meeting. At that time, Council asked the CCIDC Board to change the bylaws to allow only three members to be nonresidents rather than follow the state law which allows all members to be nonresidents. Joel Usher, who is on the CCIDC board, addressed Council stating that the Board would like to again ask Council to allow the bylaws to follow state law. He stated that, in a community as small as Columbus, there is a limited pool from which to choose. He also stated that Council has the ultimate authority to approve all members of the Board. Councilman Rankin stated that he still wanted to restrict the membership to only three members from outside the City. The Mayor stated, that while he understood Councilman Rankin's concerns, that Council has approval authority and that he had no problem with adopting the resolution as CCIDC requested. Councilwoman Gobert said that there is a lot of talent in the area that they cannot currently have on the Board. Councilman Rankin said that he would like to table the item until the full council was able to be in attendance. Councilman Schonenberg stated that he wanted to have the best people available on the Board.

Councilman Rankin made a motion to table action on the approval of Resolution 148-15. The motion died for the lack of a second.

Councilman Schonenberg made a motion to approve Resolution 148-15, Consenting to a Change in the Columbus Community & Industrial Development Corporation Bylaws. Councilwoman Gobert seconded the motion.
