City Manager, Donald Warschak, gave his report on sales tax. A copy is attached to these minutes. Warschak reported sales tax was up over the same time period last year. Sales tax was \$49,447 vs. \$40,372.

Kirk Lowe of the Columbus Little League, an at large Board member, gave an overview of their application and request. Tesch asked about the restrooms. Lowe stated the company bidding has a son in the program. Tesch requested they get a few more bids. Tesch stated he wanted further clarification on whether the LL could apply or if the City had to apply being the fields are City owned. Ridlen asked if the project could be completed by the start of the season. Lowe stated they would like it done by the first of March. Ridlen stated spectator comfort under shade is nice, but it is more of a safely issue with the back to back fields. Ridlen stated he is affiliated with the LL Board, so he would abstain from any voting. With his abstaining, there is no quorum for any action to be taken at this time. Ridlen stated a few more bids would help the application.
