The Mayor called the meeting to order at 6:30 p.m.

5. <u>City Manager's Report Including Visitors Center Project, Water Filtration Project, and TxDOT Bridge Project Updates.</u>

City Manager, Donald Warschak, gave his report, a copy of which is attached to these minutes. Warschak stated they are framing the Visitors Center and the project is moving along. Regarding the Water Filtration System Project, Warschak stated the equipment package is out for bids and are due on Wednesday, July 19. The bids will be ready for the next council meeting. Warschak concluded his report with the TxDOT Bridge Project. The gas line has been bored under the river and the contractor is currently working on making the tie-ins on each side of the river. After that, the old gas line will be abandoned.

6. Consideration and Action to Submit to Planning and Zoning Proposed Amendments to the Zoning Ordinance Chapter 14 Manufactured Homes as Requested by Code Enforcement Office, Richard LaCourse.

The recommended amendments are attached to these minutes. Mayor Dungen discussed other city ordinances in the area and how their ordinances are very similar, with the exception of the nonconforming location in section (d). He suggested shortening the timeframe from 2 years to 6 months. The recommendation will then go to Planning and Zoning for their consideration and final determination.
