5. City Manager's Report Including Sales Tax, Filtration Project, McCormick River Bank Update.

City Manager, Donald Warschak, gave his report, a copy of which is attached to these minutes. Warschak stated the sales tax payment for the month was up approximately \$7,000 from the same time period last year. Eagle Lake saw an increase while Weimar and the County as a whole decreased. Total sales tax the City received was \$109,462.71.

Regarding the Water Filtration Project, Warschak stated the contractor was in the process of getting the required bonds and insurance.

Warschak concluded his report with an update of the McCormick WWTP river bank. He stated he has had two conference calls with the Army Corps of Engineers, and a site visit was done last week. Dungen asked if we were pursuing a temporary fix through FEMA again. Warschak stated a permanent fix needs to be done. If the river rises, any temporary repairs will be washed away again.

6. Consideration and Action, if Necessary, Regarding the Annual Fire Department Report.

CVFD Chief, Dusty Dittmar, gave the report, a copy of which is attached to these minutes. He stated one issue the department is experiencing is declining membership. They are down from 40 members to 32. Dittmar stated it was very difficult to attract younger members. Recruitment was discussed along with the daytime coverage for fire calls.

He stated the Oyster Fry was a success.

Mayor Dungen thanked the fire department for their service to the community.
