1. Call to Order.

Mayor Pro Tem Chuck Rankin called the meeting to order at 5:30 p.m.

2. Pledge of Allegiance and Invocation.

Rankin led the Pledge of Allegiance and Invocation.

3. Consent Agenda:

a. Approval of Invoices

Councilman Swindle made a motion to approve the Consent Agenda as presented. Councilwoman Frnka seconded the motion.

The vote was as follows:

The motion passed.

4. Citizens' Presentations and Comments.1

Carol Braden and Doreen Alexander from the Colorado County Fair Association requested a Hotel Occupancy Tax grant of \$100,000 for upgrades at the fairgrounds. Braden stated in the past the Association had received funding. Braden commented they have not received any funds since the City started awarding the funds to the Chamber. She asked why they qualified in 2012, but they do not now, even though they now purchase more hotel rooms during the fair.

Rankin stated they could not deliberate the inquiry, but he stated the Chamber administers the funds. If the association has a valid request they should take it to the Chamber.

5. Public Hearing on the Property Tax Rate for Tax Year 2020 and Fiscal Year 2021.

Rankin opened the public hearing at 5:39 p.m.

He stated the tax rate per \$100 valuation is decreasing from last year's rate. It will be going to 0.28392 from 0.2850

There were no other public comments.

The public hearing was closed at 5:40 p.m.

6. Discussion of Budget Workshop.

City Secretary, Bana Schneider, stated there were some minor changes from the last budget Council had received. She stated the changes were for some of the estimated expenditures based on current information.

Schneider also stated there is a possibility the street seal coating will not be done before October 1st. She said she had spoken to the auditors, and she will not be able to book a payable for the contract amount. Schneider said she had not changed the budget so an amendment might have to be made if the project is not completed before the end of the fiscal year. Rankin stated a budget amendment should not be an issue.

7. Public Hearing on the Proposed 2020-2021 City of Columbus Operating Budget.

Rankin opened the public hearing at 5:44 p.m.

Rankin closed the public hearing at 5:45 p.m.

8. Consideration and Action to Approve Ordinance 235-20, an Ordinance Amending Ordinance 219-19 to Adopt a Budget for the Ensuing Fiscal Year Beginning October 1, 2020 and Ending September 30, 2021.

Councilman Swindle made a motion to approve Ordinance 235-20. Councilman Cummings seconded the motion.

9. <u>Consideration and Action to Approve a 2019-2020 Budget Amendment for Library Memorials and Donations and Associated Expenditures.</u>

Rankin stated a new donation came in today so the budget amendment has been updated from the one in the Council packet.

Councilwoman Frnka made a motion to approve the budget amendment for the library. Councilman Cummings seconded the motion.

10. Consideration and Action to Approve Library Expenditures for COVID-19 Mitigation.

Library Director, Susan Chandler, stated the items she is requesting include an automatic door opener, and permanent sneeze guards for the circulation desk and computer area. Lastly she stated she was hoping to also upgrade the book drop. Rankin asked if all of these items qualify for the

COVID funds. Schneider stated she believed they did. The City would have to justify how these items were used for COVID mitigation if we are audited.

Councilman Swindle made a motion to approve the expenditures. Councilman Cummings seconded the motion.
