He noted that the portion facing Jones Street would be 62 feet wide by 111 feet deep, and that it meets the City's requirements for minimum size. He stated that the owners were planning to sell the property, and a house would be built on it. The portion remaining which faces Travis Street will remain with the Griffin's house. Vernon Griffin stated that the proposed back lot line would be deep enough to be even with the others facing Jones Street.
