4. Citizens' Presentations and Comments¹

Debbie Damon addressed Council about "How Would You Feel?" regarding an incident that happened at her business. A copy of her statement is attached to these minutes.

Billy Kahn, current Chamber Director, introduced to Council, Kristen Cepak, the new Chamber Director upon Kahn's retirement.

Billy Kahn thanked Council for everything they have done for the Chamber over the last four and half years.

Chris Christensen addressed Council regarding the invasion happening at the southern Texas border. He stated Governor Abbott has activated the National Guard at the border due to this invasion. Some of these service people are from Columbus. Pay is low and slow. If there is some way to show support to the guardsmen on the southern border, that we are thinking of them and support them. Also, if there is a way to support them financially.

5. City Manager's Report Including Sales Tax, the Water Filtration Project Update, the Army Corp of Engineer WWTP River Bank Project Update, and Sewer Averaging.

City Manager, Donald Warschak, gave his report. A copy is attached to these minutes. Regarding sales tax, Warschak reported the payment to the City was \$141,208, up from \$125,824 over the same time period last year. The County and the City of Weimar also saw increases, while the City of Eagle Lake saw a decrease.

Regarding water filtration, all three plants are in service and functioning satisfactorily.

Regarding the Army Corp project, the contractor has mobilized and excavation has begun.

Regarding sewer averaging, it will begin December 15, and run until February 15. Water usage during this time period will be used to calculate the sewer rates for the upcoming year for residential customers.
