City Manager, Donald Warschak, gave his report. A copy is attached to these minutes.

Regarding the McCormick WWTP Riverbank Project, Warschak reported the contractor has completed the installation of the outfall line and structure. Today they were installing the geotextile fabric and rock rip-rap on the slope of the riverbank.

Regarding the MLK Street Sidewalk Project, Warschak reported the contractor is making good progress. They are currently working on the section located between Back Street and BUS Hwy 71 and the section between BUS Hwy 17 and Prairie Street. Curbing and sidewalk are being installed in these areas. The pavement widening will start once these improvements are complete. Upon completion, painting of crosswalks will be done.
