3.1. Presentation of Preliminary and Final Plat Data for an Application Filed by Deborah Herring for a Replat of a 4.364 Acre Tract Situated in the W.B. Dewees League (A-18) to the City of Columbus, into Five (5) Tracts (0.4419 Acres (Lot 1), 0.5133 Acres (Lot 2), 0.3855 Acres (Lot 3), 0.3810 Acres (Lot 4) and 2.6423 Acres (Residual)).

City Manager, Donald Warschak, gave the location of the property to be divided. Two lots will front Walnut (Hwy 90) and two will front Oak Cluster. He stated all lots would meet the minimum lot requirements as set out in the ordinance. He discussed the drainage of the property. Warschak stated drainage issues would be addressed during the building permitting process.

Property owner, Deborah Herring, stated she asked the surveyors for the property that would drain to Highway 90, and these were the lots that naturally drain in that direction. Nearby property owners, Brenda Wyman, and Ken Braden, expressed their concerns over drainage.
