1. Call to Order.

Vice President Andy Nunmaker called the CCIDC meeting to order at 5:30 p.m.

2. Pledge of Allegiance and Invocation.

The Pledge of Allegiance and Invocation were led by Vice President Andy Nunmaker.

5. Citizens' Presentations and Comments.

Billy Kahn of the Columbus Chamber joined the meeting via telephone. He had no comments.

6. City Manager's Report: Sales Tax.

City Manager, Donald Warschak, gave the report on sales tax, stating sales tax was up compared to this time period last year. This is the May payment for March collections. The sales tax portion for CCIDC was \$59,408 compared to \$52,000 last year. Warschak stated the county, and the Cities of Eagle Lake and Weimar all saw increases as well.

7. <u>Discussion and Action, if necessary, to receive Community Development Grant funds back from the</u> Chamber of Commerce due to the cancellation of Magnolia Days.

Michael Ridlen made a motion to accept the grant funds back from the Chamber. Chuck Hall seconded the motion. The roll call vote, via telephone and in person, was as follows:

Tesch stated \$50,000 has now been budgeted for the COVID-19 City Utility Assistance Grants. At this time, only about \$7,700 has been applied for and approved for payment. He stated he has been out encouraging businesses to apply. He requested other members do the same. Tesch also suggested that maybe after the first initial deadline of June 1, we do another advertising campaign and remind businesses there are still funds available if we have them.
