5. City Manager's Report: Sales Tax SEPT 2022 SALES TAX.pdf

City Manager, Donald Warschak, gave his report. A copy is attached to these minutes. Warschak reported sales tax for this period was \$47,637.69 (down), compared to \$49,498.57 over the same period last year. The County, City of Weimar, and City of Eagle Lake all saw increases. City Secretary, Bana Schneider, looked back and there were a couple catch up payments during that period last year making it higher than normal. Without those payments, the payment was relatively flat compared to last year.
